1. The Kyrgyz Republic has received financing from the Asian Development Bank (ADB) toward the cost of Almaty–Bishkek Economic Corridor Regional Improvement of Border Services Project. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Border Service of the State Committee for National Security of the Kyrgyz Republic (“the Employer”) invites sealed bids from eligible Bidders for the construction and completion of Construction of the Border Crossing Point (BCP) facility at Ak Tilek (“the Works”).
3. Open competitive bidding will be conducted in accordance with ADB’s Single-Stage: Two-Envelope (1S2E) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
  - (i) Participation as a contractor, Joint Venture partner, or Subcontractor, in at least two contracts that have been satisfactorily and substantially completed within the last 10(ten) years (from 2015 to 2024). and that are similar to the proposed works, where the value of the Bidder’s participation under each contract exceeds USD 8,000,000.00 (eight million) The similarity of the Bidder’s participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6 (Employer’s Requirements) of the Bidding Documents.

  - (iii) Minimum average annual construction turnover of USD 6,700,000.00 (six million seven hundred thousand), calculated as total certified payments received for contracts in progress or completed, within the last 3 (three) years (2022, 2023, 2024).

  - (v) The Bidder must demonstrate that its financial resources meet or exceed the total requirement for the Subject Contract of USD 950,000.00 (nine hundred fifty thousand).
