National consultants' forum

The forth national consultants' conference "Development of professional standards in consulting" took place on 17 December 2014 in Bishkek.

The forum served as a platform for identifying the needs in professional standards of consulting companies and building partnership among participants. The conference participants discussed different professional standards such as Certified Management Consultant (CMC), Project Management Professional (PMP), Certified Performance Technologist (CPT), Certified International Professional Accountant (CIPA), as well as ethical issues in consulting, relevance of professionalism and standards of consulting processes.

The forth national forum brought together over 100 participants, including representatives of international organisations, educational institutions, entrepreneurs and consultants.




Annual consultants review 2014

We are pleased to share the results of our Annual Consultants Review (ACR) conducted in the summer of 2014. Please note that the results presented here are not representative of the national consultancy market and must not be cited out of context.

Most of our 88 respondents are very small, local consulting companies. The majority (73%) of our respondents reported having grown their business in 2013 compared to 2012. 56% of respondents' employees are women, while 1% have female ownership and 25% have a female Director or CEO. 67% of responding companies carry out subsidised projects. On average, over a quarter (28%) of respondents' projects are subsidised by government or donors. Most of them are located in Bishkek.



Typically their clients have less than 10 employees. 83% of respondent's clients are in the micro segment (less than 10 employees). 16 % of clients are reportedly in the medium segment (50-249 employees) and only 1% are in the small segment (10-49 employees). On average, our respondents reported to have 49 clients per year, of which 28% are new clients. A quarter (25%) of respondents carry out projects abroad. 69% of respondents perceive that competition has grown in their area over the past year.




Many respondents benefit from professional development opportunities. 67% of respondents participated in professional development training in the previous year. Over a third (34%) of respondents participated in trainings organised by the EBRD.





Our contribution to business improvement





Launch of Certified Management Consultant (CMC) certification

Despite the growing number of local consultants and consulting firms in the Kyrgyz Republic, the level of professionalisation and recognition among stakeholders remains relatively poor. In order to address this, the EBRD supports the qualification of selected local consultants who will become the standard bearers for the industry in the Kyrgyz Republic, support the crea-

tion of a training framework for continuous professional development and raise the profile of professional recognition among consultants, the private sector and stakeholders within the country.

The whole certification process, including seminars and coaching is being conducted by the Institute of Management Consultants of Ukraine and is held in Russian language.

On November 14, IMC Ukraine held the first introductory training and interviews with potential CMC consultants.

As of now, out of 30 applications from the Kyrgyz Republic, Tajikistan and Kazakhstan, 12 were admitted for further certification. The next training on "Management consulting essentials and ethics" is planned for January 15-18 and is open for everybody interested. EBRD marks completion of Phase III of business advisory programme, with 400 SMEs supported

On 18 November, 2014 we held a ceremony to mark the completion of Phase III (2010-14) of advisory support to small and medium-sized enterprises, funded by the government of Switzerland.

Over the course of Phase III (2010-14) the EBRD has helped over 400 SMEs in the Kyrgyz Republic to access business advice to transform their businesses, committing over €2.6 million in funding and exceeding the target of 280. The EBRD has drawn on the know-how of a network of local consultants to help transform a wide range of businesses, looking at areas including strategy, marketing, operations, quality management, energy efficiency, financial management and beyond.



This advice has had a tangible impact

on the performance of the assisted enterprises: 93 per cent increased their turnover, while 60 per cent reported growing their workforce by an average of 14 per cent. Moreover, three-quarters of assisted enterprises were located outside of Bishkek, highlighting the EBRD's commitment to providing advice also in under-served areas.

In this time, the EBRD has also built a stronger, more competitive market for business advice. Although it is still in the early stages of formation, the EBRD has created a network of 163 active consultants and supported the establishment of an active Institute of Management Consultants (IMC) of the Kyrgyz Republic, which currently has 70 members. Swiss funding has also promoted the professionalisation of the local consultancy market by improving the skills and knowledge of local consultants in the Kyrgyz Republic via training courses and conferences.

The completion ceremony gathered representatives of government, international organisations and business associations.

Know How campaign outreach in Talas and Karakol

The newly launched Know How campaign continues to reach far ends of our country. Now, presentations were held in Karakol and Talas, targeting more than 200 beneficiaries and stakeholders.
